General Instructions of Talent Hunt Program–Batch 2019

Students are forewarned that while at IBA Karachi they should NOT associate themselves with any of the following activities. Indulging in any of the following activities will be taken as a misdemeanor / act of indiscipline and breach / violation of the IBA students Code of Conduct which would lead to award of appropriate penalty to the concerned person(s);

- ✓ Failing to comply with laid down/ instructed rules /regulations or instructions /orders.
- ✓ Giving false information or willful suppression of information, cheating or deceiving.
- ✓ Participating in ragging, physical abuse of another person, or conduct which threatens or endangers another, or making verbal or physical threats which cause reasonable apprehension of harm.
- Use of indecent/foul language, threatening, cursing or harassing a fellow student or any member of the IBA. Immoral behavior / negative behavior that interferes with activities authorized, sponsored by IBA, or is in breach of any rule of public morals, such as; Use of immodest dress or failing to comply with the dress code.
- ✓ Disorderly behavior, such as shouting, abusing, quarrelling, theft, fraud, fighting, physical assault and insolence on the campuses or hostels of IBA.
- ✓ Disrupting or disturbing the proceedings of a class including showing reluctance to follow / comply with the instructions of the teacher.
- ✓ Use of <u>cell phone</u> including texting, attending phone call is forbidden in classroom and lab sessions.
- ✓ <u>Attendance</u> in each class will be taken daily by the teacher/ mentor as soon the class starts.
- ✓ <u>Late comers</u> are promptly marked "**Absent**" even if they are late by one minute.
- ✓ <u>Poor performance</u> in the class and in the test/exams will disqualify student from the scholarship program.
- ✓ All the students who will be attending training in Batch 2019 will appear in the IBA admission test held on July 07, 2019 for BBA/BS(AF)/BS(SSLA) and on July 28, 2019 for BS(CS/EM) admissions. Brief on IBA Hostels (General Instructions)

During stay at the IBA Hostel, residents are required to abide by hostel rules, failing which they may risk expulsion both from the Hostel and the IBA. Do note the following excerpts of hostel regulations:

- i. Residents shall be under the disciplinary control of the Superintendent.
- ii. Residents shall sign a receipt of Hostel property in their rooms and shall be responsible for any loss or damage.
- iii. Residents are not allowed to change their rooms of their own accord, or allow a guest to stay overnight with them.
- iv. Residents shall not be allowed to make any structural additions or alterations in their rooms, nor install/fix any electrical gadgets or fittings/fixtures anywhere in the Hostel without prior approval of the Superintendent/Registrar.
- v. Residents should not disturb fellow residents by playing music or any instruments at a high volume, or cause any other discomfort.
- vi. Silent hour should be maintained strictly after 11:00 p.m. in the Hostel so that residents can devote time to studies.
- vii. Residents are not allowed to use electrical appliances, except a Laptop.
- viii. Residents are advised in their own interest not to keep expensive articles or valuables in their safe custody and Hostel Management will not be responsible for any loss/damage.
- ix. Smoking is prohibited in IBA Campus and Hostel premises.
- x. Residents are prohibited from keeping any kinds of arms, ammunition or intoxicants in their possession. Non-observance of this rule shall be severely dealt with. Residents who are found in intoxicated condition may be expelled from the Hostel immediately.
- xi. Residents once expelled from the Hostel shall not be admitted again or allowed to stay in the Hostel.
- xii. Residents shall be under obligation to conform to all the rules and regulations that may be enforced in the Hostel from time to time.
- xiii. All residents should be in the Hostel by 11:00 p.m.
- xiv. All residents should ensure that persons visiting them fill in the necessary particulars in the Visitors' Book.
- xv. No private parties or functions can be arranged by individuals or groups without the prior permission of the Hostel Superintendent and Director THP.
- xvi. Residents are requested not to enter into any conflict with the any other students or employees of the Hostel. The complaints against the student's/ Hostel staff should be brought to the notice of the Hostel in-charge/Superintendent.
- xvii. No resident(s) shall be allowed to take any crockery into his/her room.
- xviii. No resident shall open the door of another resident's room without his/her permission.
- xix. All cases of illness should be immediately reported to the IBA Hostel In-charge, who shall make necessary arrangements for medical help.
